## IN THE PAST 12 MONTHS ALONE, APMA HAS FOUGHT FOR PARITY AND PROVIDED ITS MEMBERS WITH:

- 25 coding and reimbursement webinars, all of them free;
- 18 comment letters to CMS, FDA, and others to promote parity for DPMs;
- 500+ meetings with policymakers on Capitol Hill;
- 200+ conversations with state component leaders to advance state advocacy initiatives;
- 5,000+ touchpoints with state legislators and staff via the National Conference of State Legislators;
- 500+ calls, emails, and other contact with collaborating organizations to advocate for DPMs;
- 60+ private and public insurance advisors, dedicated to supporting APMA members;
- 78 faculty invitations for The National, the must-attend meeting for every podiatrist;
- 6 instructional articles on reimbursement in APMA News;
- 96 issues of JAPMA, APMA News, News Brief, and Weekly Focus, combined;
- 228 student scholarships;
- 18 college visits by APMA leaders to help support the next generation of DPMs;
- 1.5 billion media impressions promoting the importance of foot health to the public;
- \$4,000 per year on average in savings for members who follow APMA's MACRA guidelines; and
- 1 tremendous national qualified clinical data registry in development.

#### LEGISLATIVE, REGULATORY EFFORTS

- APMA successfully advocated for right to supervise HBOT—there is still more to be done
- Clarification on 59 Modifier—in person meeting with CMS and they implemented our suggestions
- APMA defeated O & P proposed rule
- Working on quality measures and outcomes to be included in CMS Quality Payment Program



## PROPOSAL FOR SEPARATE PODIATRY E/M CODES DEFEATED

- CMS Proposed Rule to establish separate G codes for Podiatry E/M services defeated
  - Proposal would have isolated podiatry and resulted in net -4% reimbursement for E/M services provided by podiatrists

## LEGISLATIVE UPDATE: ADVOCATING FOR YOU

 Senator Cassidy introduced VA Provider Equity Act in the Senate (SB 1871) and then added to Caring for Our Veterans Act (SB 2193)—added to and passed into law as part of the VA MISSION Act of 2018!!

Helping Ensure Life- and Limb-Saving Access to Podiatric Physicians Act (HELLPP Act) re-

introduced (HR 1542/S 1533)





### VA PARITY BILL PASSED!

Podiatrists recognized as podiatric surgeons in the VA and placed in the same pay band as MDs and DOs with ability to be promoted in administrative positions
